

This Privacy Policy indicates the scope in which Social Organics Private Limited collects, uses, maintains and discloses information collected from users (each, a "User") of the Salespin mobile application ("App"). Please read our privacy policy carefully to get a clear understanding of how we collect, use, protect or otherwise handle your Personally Identifiable Information in accordance with our website.

### **Personal identification information**

We may collect personal identification information from Users in a variety of ways, including, but not limited to, when Users visit our App, register on the App, fill out a form, and in connection with other activities, services, features or resources we make available on our App. Users may be asked for name, email address, mailing address, phone number of the user and the individuals or firms or companies (business contacts) that the user interacts in the course of usage of the App. The App will also seek permissions for access to information stored and functions on the phone including but not limited to location data, camera, microphone, contacts, email, phone, sms Other information that the App may collect include but not limited to documents related to tax identification, address proof documents, identity proof documents. We will collect personal identification information from Users only if they voluntarily submit such information to us. Users can always refuse to supply such information, except that it may prevent them from engaging in certain App related activities or the use of the App in its entirety.

### **Non-personal identification information**

We may collect non-personal identification information about Users whenever they interact with our App. Non-personal identification information may include but not limited to the Phone IMEI number, type of phone, technical information about Users, means of connection to our App, such as the operating system and the Internet service providers utilized and other similar information.

We will also collect through the App information related to transactions and other details entered by the User about Business Contacts including but not limited to inventory supplied, orders created, transaction details including payments, credits, returns, location of the place where such transaction took place, pictures, receipts, bills, vouchers, invoices, tax information, commission information, distance, time, client/customer information, feedback, product information.

### **How we use collected information**

Social Organics Private Limited may collect and use Users personal information and other information for the following purposes:

1. Track User's performance, market demands, market trends and related data.
2. Evaluate User's performance
3. Product and service improvements
4. Generate business leads and provide products / services required by the User and the Business Contacts.
5. Reach out for feedback and receive feedback
